4. First-Aid Measures

Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). Remove affected person from danger area. Immediately remove contaminated clothing. In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

If inhaled:

5. Fire-Fighting Measures

Extinguishing media

Suitable extinguishing media: carbon dioxide, alcohol-resistant foam, dry powder, water spray

Fire will produce dense black smoke. Inhalation of dangerous decomposition products may cause serious damage to health.

6. Accidental Release Measures

Personal precautions, protective equipment and emergency procedures

Avoid breathing vapours. For non-emergency personnel: Use personal protective clothing. Ensure adequate ventilation. Keep away from sources of ignition. Environmental precautions

Methods and material for containment and cleaning up

7. Handling and Storage

Precautions for safe handling

When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. particulates and solvent vapour concentration has fallen below the exposure limits. Avoid inhalation of vapour and spray mist. The workplace should be equipped with an emergency shower and eyerinsing facility. Avoid contact with the skin, eyes and clothing. Handle in accordance with good industrial hygiene and safety practice.

Protection against fire and explosion:

Avoid all sources of ignition: heat, sparks, open flame. Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers.
